

In May 2017, AMP hosted advocacy events organized by the Professional Relations Committee and the Economic Affairs Committee. AMP President Federico A. Monzon, MD led a "Lunch and Learn" on May 8, where representatives from six cancer patient advocacy groups discussed recent advances in molecular testing and how the developments affect the treatment and prevention of cancer.

On May 17, Economic Affairs Committee Chair Samuel K. Caughron, MD headed a virtual meeting focusing on standards for and challenges of clinical utility for molecular testing. Over 15 representatives from Medicare Administrative Contractors and private insurance companies participated in the conversation. During the discussion, various case studies were used to exemplify the issues regarding clinical utility that labs and payers face. AMP's advocacy efforts will continue through the summer with additional Lunch and Learn and payer engagement events already in the works.
